./, I am pleased to enclose a letter sent recently from the Commission to several ACs about eel. The Commission has decided to launch a wide-ranging consultation and is asking for concrete suggestions on measures that would facilitate implementation of the ICES advice on eel. This letter came close on the heels of a letter I sent to the Commission and Member States, with a statement from the BSAC on views and advice on other factors that hamper eel recovery and that require immediate and urgent attention and work. The Commission has just replied to the BSAC statement, and informed that it has also written to Member State Regional groups.¹ In the BSAC, we are thinking about how best to develop a response to the Commission's request, and we will begin this work in the new year. I find it very important from a Baltic perspective. We would like to discuss this with Member States so we can put our heads together and formulate a Baltic response. I would very much like to suggest a meeting with you in the new year to deal with this.

I would also like to refer to my letter to you of 29th November 2021 (BSAC 2021-2022/27) about our initiative to hold a joint HELCOM, BALTFISH and BSAC meeting to inform of and discuss those actions from the adopted HELCOM BSAP that are relevant to fisheries and fisheries management.²
